She joined AIG in 1997 and, after five years in Management Liabilities Underwriting in Dublin and London, she transferred to Financial Lines in the US. She has worked in both commercial directors’ & officers and financial institutions environments as chief underwriting officer for financial lines home office, as well as global manager of the financial institutions practice before returning to London in 2010.

In 2012 Ms McNamee won the Women of Achievement Award in Insurance Services. She holds a Bachelor of Science Degree in Engineering from Trinity College, Dublin.
