He later became Chief Underwriting Officer for Financial Lines UK and Ireland in 2004, and two years later, was appointed Financial Lines Manager UK and Ireland.

In 2008, Mr. Baldwin was appointed Senior Vice President of AIG International Commercial Lines, with responsibility for the Financial Lines portfolio of AIG International. In 2014, he became Managing Director and Head of Distribution for AIG's Europe, Middle East & Africa (EMEA) Region, with responsibility for market execution in its eight networked zones.
