Comprehensive cover

Agreed value

New car replacement

Guaranteed replacement value

New vehicle purchases

Rest assured, as soon as you purchase a new car we automatically cover it on a fully comprehensive basis for 5 days. You and your spouse are fully covered to drive away any car up to a value of £500,000.

Hire vehicle provision

To simplify your life and ease your claims experience, we will cover the cost of a temporary car of similar specifications while your vehicle is being repaired or until your theft claim is fully resolved.

Rental vehicle cover

We cover as an insured vehicle any motor vehicle that is rented by you or your spouse. This protection is provided up to 90 days anywhere in the territorial limits.
